4. First-aid Measures

SKIN CONTACT: Remove contaminated clothing and wash the skin thoroughly with soap and water after work. Wash contact area thoroughly with soap and water. Get medical attention if irritation or rash develops or persists. Remove contaminated clothing. Launder clothing before re-use.

EYE CONTACT: Rinse immediately with plenty of water. Flush eyes with plenty of water for 15 minutes, while holding the eyelids apart. Check victim for contact lenses and remove if present. Get medical attention if irritation persists.

INHALATION: Move to fresh air. Remove victim to fresh air. If breathing is difficult, oxygen should be administered by qualified personnel. Get medical attention if you feel unwell.

5. Fire-fighting Measures

6. Accidental Release Measures

PERSONAL PRECAUTIONS : Ventilate closed spaces before entering them. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Keep upwind.

METHODS AND MATERIALS FOR CONTAINMENT AND CLEANUP: Leaking cans should be placed in a plastic bag or open pail away from ignition sources until the pressure has dissipated. Collect liquid spill with an inert absorbent material and place into a suitable container for disposal.
