### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** Remove from exposure area to fresh air. Treat symptomatically and supportively.

**Skin contact:** Rinse affected area with large amounts of water until no evidence of product remains. Get medical attention if irritation persists.

**Eye contact:** Rinse eyes with plenty of water for at least 15 minutes while holding eyelids open. Get medical attention if pain or irritation persists.

**Ingestion:** Dilution by rinsing the mouth and giving water or milk to drink is generally recommended. Contact physician or local poison control center.

#### Most important symptoms and effects, both acute and delayed

After eye contact: May cause mild eye irritation. After skin contact: Repeated or prolonged exposure may cause irritation. After Ingestion: Ingestion of large amounts may cause some gastrointestinal discomfort including nausea, vomiting, abdominal pain and diarrhea.
