4. FIRST AID MEASURES

Description of necessary measures

Inhalation: Remove from exposure area to fresh air. Treat symptomatically and supportively.

After eye contact: Moderate to strong irritation of the eyes (redness, swelling, burning, watering eyes). After skin contact: Repeated or prolonged excessive exposure may cause irritation.
