SECTION 2: HAZARD IDENTIFICATION

EMERGENCY OVERVIEW

CAUTION: This product is a clear to pale yellow or clear blue liquid with a pleasant odor. Direct contact with eyes may cause irritation, with possibility of corneal injury if not removed promptly.
