Carcinogenicity: In 1996, the IARC reevaluated carbon black as a GROUP 2B carcinogen (possible human

carcinogen). This evaluation is given to carbon black for which there is inadequate human evidence, but sufficient animal evidence. The latter is based upon the development of lung tumors in rats receiving chronic inhalation exposures to free carbon black at levels that include particle overload of the lungs. Studies performed in animal models other than rats have not demonstrated as association between carbon black and lung tumors. Moreover, a two-year cancer bioassay using a typical toner operation containing carbon black demonstrated no association between exposure

and tumor development and rats.

STOT - Multiple Exposure: In a study in rats (H. Muhle) by chronic inhalation exposure to a typical toner, a mild to moderate

degree of lung fibrosis was observed in 92% of the rats in the concentration (16 mg/m3) exposure group. And a minimal to mild degree of fibrosis was noted 22% of the animals in the middle (4mg/m3) exposure group. But no pulmonary changes in the lowest (1 mg/m3) exposure group,

the most relevant level to potential human exposure.
